For the teachers working in Govt. school their appointment letter must be countersigned by BEEO/AEO/SDO/DSE,DEO or any other competent Govt. Authority.
4. Proof of working teacher till date from the concerned school.
5. Caste Certificate (For reserved Category) issued from SDO/DM.
6. Proof of recognition of school where teacher is working either from Bihar Govt./Central Govt. or any recognised board.
7. Certificate of Handicappedness (*where applicable*).
8. Entrance Test Admit card. (*Original*).
9. 2 (Two) passport size coloured photographs.
10. A Bank Draft of **Rs. 40,000/-** as course fee in the form of Bank Draft issued from any Nationalized Bank of India in favour of **Director, DDE,M.U,BodhGaya** payable at **BodhGaya**.
11. A Demand Draft of **Rs. 6050/-** towards supply of Course materials at the time of admission. The DD will be in favour of **Director, DDE,M.U,BodhGaya** payable at **BodhGaya**.
12. Rs. 1850/- in cash towards outsourced purchase of Syllabus, Carry Bag, Assignment Copy (8 nos.), Lesson Plan (2 nos.), Enrolment Slip & Laminated Identity Card.
13. Rs. 1000/- in cash "दूरस्थ शिक्षा छात्र कल्याण कोष" ।
